Rising Star Award

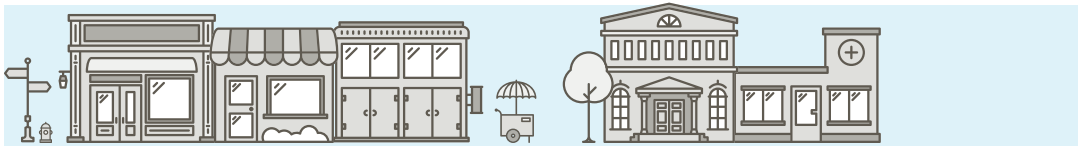
